Guidelines

(1) *General Guidelines*: The abstracts should be addressed to a broad, non specialist public in a form, which would encourage the dialogue between disciplines. Technical details should be avoided.

(2) *Length of the paper*: four pages: more than three and less than five pages (the fourth page has to be at least partly filled) (including the abstract and the references)

(3) *WARNING*: Please do not number the pages.

(4) *Format*: Main text: Times New Roman, 10 pt; single space. Biographic data at the beginning and references at the end: 8 pt.; single space.

(5) *Footnotes*: Footnotes should be avoided; parenthetic inserts within the text are preferred.

(6) *Illustrations*: You may have Figures (with legends Fig. 1, Fig. 2, etc.), Graphs (with legends Graph 1, Graph 2, etc.), and Tables (Table 1, Table 2, etc.) interrupting the text. These will be printed in black-and-white. It is the author's responsibility to obtain written permission to reproduce copyright materials, including figures, long quotations, etc.

(7) *Outline*: You may organize the texts in to chapters and sub-chapters with a small Introduction setting out the topic, although it is not necessary. The length of the paper (including the abstract and the references), should be four pages: more than three and less than five pages (the fourth page has to be at least partly filled).

(8) *Citations in the text*: Surname, year, page (chapter, or other number(s), if necessary). For example, Abel (1952, pp. 10-12) stated ...; the problem is solved by some authors (Abel, 1952, pp. 21-23; Weyl et al., 1953a, chap. 2).

(9) *References*: A list of references should be arranged at the end of the paper in alphabetical order by authors' names. The title of books and journals should be written in italics with capitalization. Times New Roman, 8 pt., single space, with indent – see sample here below.
